TERMS AND CONDITIONS

I and my natural parent/ guardian (if under 18 years of age) and applicant for the **STUDENT AMERICAN INTERNATIONAL exchange** program, agree to the following: My tour begins when I get off my flight and finishes when my I am taken back to the airport at the end of the tour. I agree to release and hold harmless, STUDENT AMERICAN INTERNATIONAL, its officers, and employees, my exchange program and employees thereof, my school and chaperone from, and not to sue such parties for any claims, demands, liabilities and causes of action I may have arising out of action, or connected to, personal injury, death or property damage I may suffer resulting from any cause what-so-ever, other than actual negligence of such persons. Without limiting the generality of the foregoing, I release such persons from and agree not to sue such persons for, any physical property damage which I may suffer from acts of God, strikes or government restrictions, terrorist activities, or for acts or omissions of persons or agencies not directly controlled by STUDENT AMERICAN INTERNATIONAL, including without limitations, airlines, bus companies, cruise lines, railways, hotels, restaurants, attractions, shareholders and employees, my school, my exchange program and chaperone from any claims, demands, liabilities, causes of action and costs and expenses arising out of personal injury or damage that I either cause or contribute to, while participating on an, STUDENT AMERICAN INTERNATIONAL program and from any financial obligations which I may incur on my own behalf. I understand that the air carrier's liability for loss or damage to baggage or property, or for death or injury to persons, is limited by their tariffs, or the Warsaw Convention, or both. I understand and agree that STUDENT AMERICAN INTERNATIONAL, shall have not responsibility to or for me when I am absent from, supervised STUDENT AMERICAN INTERNATIONAL activities.

I agree to abide by STUDENT AMERICAN INTERNATIONAL regulations and the directions of my chaperones and trips leaders during the STUDENT AMERICAN INTERNATIONAL trips. Failure to do so may result in terminating me from the STUDENT AMERICAN INTERNATIONAL trips immediately. I understand that termination from a trips due to failure to adhere to regulations and directions, will result in my being returned early to my host community at my own cost. Furthermore, I understand that my exchange program and natural parents will be advised of the infringement and agree not to hold STUDENT AMERICAN INTERNATIONAL responsible for actions taken by my exchange program or parents. STUDENT AMERICAN INTERNATIONAL reserves the right to dismiss any student from the exchange program who is returned early from one of their sponsored trip.

All participants are forbidden to possess or use any tobacco products, drugs and alcohol, including beer and wine. I understand that a curfew will be enforced each night at which time I will be expected to be in my assigned room. I understand that to disobey such rules or directions is to waive my right to a refund of any part of the tour fee and that I will be returned to my host community at my own expense. I understand that STUDENT AMERICAN INTERNATIONAL reserves the right to make necessary changes in our itineraries, departure dates and to use substitutions as necessary.

This agreement constitutes the entire agreement between, my exchange program, STUDENT AMERICAN INTERNATIONAL, and myself, with reference to the subject matter referred to herein and I do not rely upon promises, inducements or agreements not herein, including, but not limited to, any oral statements made to me by any agents or employees or persons or by my exchange program STUDENT AMERICAN INTERNATIONAL. This agreement may only be amended or modified in writing.
